QUEEN'S SPEECH BEARS OUT LAW SOCIETY'S 'WORST FEARS':

The Law Society has slammed government plans to set up an FBI-style crime fighting agency, saying the move has borne out its 'worst fears'. The organisation says it fears police will be able to arrest people for all offences, not just those carrying custodial sentences as at present, or even for refusing to give their name and address, after a shake-up announced in the Queen's Speech.

The Serious Organised Crime and Police Bill is to bring about a radical shake-up of the organisations and powers to fight major crime. It will also overhaul the powers of police officers contained in the *Police and Criminal Evidence Act 1984*, extend the powers of community support officers and create a new offence of religious hatred. The bill is also likely to include a new 'super-warrant' that can be used more than once and targets offenders with more than one address.

Law Society chief executive Janet Paraskeva rapped the proposed legislation, saying that giving police the power to arrest, no matter how minor the suspected offence, would disrupt the balance between civil liberties and police needs. She said: 'This raises serious questions of police accountability and effective judicial oversight. The warrant weakens judicial control over the exercise of a very serious interference with the rights of the citizen, and appears intended to apply to every property in relation to which a suspect would have rights of occupation, control, or even access.'

She added: 'The government is in serious danger of overstating the threat to public order and national security and bringing in Draconian new laws which will take away centuries of hard won rights. Taken together with other plans to tackle terrorism and law and order, we fear that they are taking a serious step in the direction of a police state.'

LAW FIRMS MUST BOOST DIVERSITY - LAMMY:

City law firms should do more to boost diversity and stop favouring Oxbridge graduates, Minister for Constitutional Affairs David Lammy has said. In a speech to the standing conference on legal education this week, he said that women and ethnic minorities are penetrating the legal profession very slowly.

'What are the big law firms and chambers doing to ensure they have a more diverse make-up?' asked Lammy. 'It is not enough to import diversity from overseas, or sit back and hope that the problem will fix itself. If those



with the resources at their disposal can't lead the way, how can we expect others to?' He noted that 78% of Oxbridge students have their fees paid by a professional sponsor, compared to 27% from new universities, according to government data. 'Is it any wonder then, that students who achieve excellent results but go to a new university don't succeed when firms do not sponsor them?' said Lammy.
